



# The rules for the renting and usage of the flags from the Citizen Services

National flags and other flags can be rented from the Citizen Services. The rental period will be agreed upon when retrieving the flags.

The flags can be retrieved from the Citizen Services. The Citizen Services will not mail the flags.

Payment for the flags will be charged based on the rental period. The prices:

Weekdays:

The price for one flag is 15 €/day. The price for additional days is 5 €/day. If one rents more than three flags at once, the price for these flags is 5 €/day/flag. 24 % VAT is included in the prices.

Weekend:

The price for a weekend for one flag is 30 €. If one rents more than three flags at once, the price for these flags is 15 €/weekend/flag. 24 % VAT is included in the prices.

If the return date is a weekday holiday, that day won't be charged for. If the flag is returned before 12 am, that day won't be charged for. If the flag is retrieved after 2 pm, that day won't be charged for. The minimum payment is for one day. The renting of the flags will be payed with an invoice. Necessary information for the invoice must be provided at the latest when returning the flags. The person renting the flags must sign the rules for the renting and usage of the flags. You can print out the rules and sign them in advance or they can be signed when picking up the flags from the Citizen Services.

After the rental period the flags must be returned to the Citizen Services. The flags must be returned dry and folded.

The one who rents the flags is responsible for the flags from the moment the flags are retrieved until the flags are returned to the Citizen Services.

According to the Finnish law (Laki Suomen lipusta, 8 §) anyone who publicly defiles the Finnish flag or uses the Finnish flag disrespectfully in public or removes without permission a publicly presented Finnish flag can be fined for the offense.

The one who rents the flags must also respect the flags of other countries.

The one who rents the flags must make sure the flags are dried indoors and following instructions.

Citizen Services must be informed immediately if the flags are damaged.

The flags will be checked after return and any damage or faults will be informed to the one who rented the flags as soon as possible. The possible prices for any compensations will be given when they are clarified. The one who rents the flags is responsible for paying for any damaged or lost flags.

The one who rents the flags agrees to these terms completely. By renting the flags one agrees to have read, understood and accepted all these terms for the renting and usage of the flags.
